

Transferring from the BA to another UQ degree

Information for students planning to transfer from Bachelor of Arts to

Bachelor of Economics/Bachelor of Arts or Bachelor of Economics

The sample enrolment plans below are for students who are studying in the Bachelor of Arts in 2023 who hope to

- transfer into the Bachelor of Economics mid-year 2023; or
- add Economics as a dual degree with Arts, mid-year 2023; or
- transfer into the Bachelor of Economics or Bachelor of Economics/Bachelor of Arts in 2024.

These plans have been approved by the Faculty of Humanities and Social Sciences and the Faculty of Business, Economics and Law, and are provided as a guide only. The suggested courses are not compulsory, and many others are available.

Remember:

- To satisfy the Bachelor of Arts program rules, in their first year of study **all BA students must complete their first 8 units of courses the BA course list** with the exception of General Elective Courses (see <https://future-students.uq.edu.au/study/programs/bachelor-arts-2000> to check the full Bachelor of Arts Program Requirements).
- Students will need to satisfy subject prerequisites AND obtain grades that will derive the required OP/entry rank for the *relevant program*. These are often best achieved by enrolling in courses they enjoy and therefore should consider their choices carefully. Students may wish to contact UQ Admissions to discuss how their entry rank will be calculated on the basis of their academic history.
- Students intending to change programs mid-year in 2023 or 2024 should familiarise themselves with all relevant rules and procedures. More information is available from:

You cannot receive credit for general electives towards the BEcon component of the dual BEcon/BA, but you may receive limited credit for Economics electives at level 1. ECON1200 can be granted as a BEcon Flexible Core course in the dual program if not pursuing a major for the BEcon component.</p> <p>NOTE: MATH1040 will meet the Mathematical Methods prerequisite for entry to the BEcon but will NOT be granted as credit towards the BEcon.</p>			

***If commencing a Bachelor of Arts in Semester 2 students will not be able to enrol in courses not on the BA course list (e.g. ECON1050) as they will need to meet the first 8 unit Program Rule requirement.**
